ORDER:-

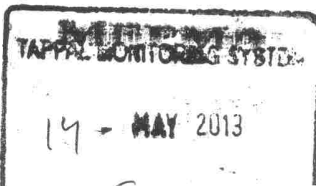
In the reference 1st read above, revised comprehensive guidelines were issued for construction of Markets/Shopping Complexes on Municipal Lands under Good will Auction basis.

In the reference 2nd read above, the Commissioner & Director of Municipal Administration, A.P., Hyderabad has submitted the proposals for reservation of 10% of shops in all Urban Local Bodies and Urban Development Authorities to Town Level Federations/Slum Level Federations in the State. He has submitted that the Mission Director, Mission for Elimination of Poverty in Municipal Areas, Hyderabad has requested to reserve 10% of shops built by Urban Local Bodies to Town Level Federations/Slum Level Federations and such reserved shops shall be auctioned among Town Level Federations/Slum Level Federations.

Government after careful examination of the proposal hereby agree to the proposal of Commissioner & Director of Municipal Administration, A.P., Hyderabad subject to review for reservation of 10% of shops in Tirupati Municipal Corporation, all Urban Local Bodies and Urban Development Authorities to Town Level Federations/Slum Level Federations initially, as per other guidelines issued in G.O.Ms.No.21, MA, dated: 18.01.2013 and also the following conditions:

- i) To consider reservation of 10% of the shop rooms constructed by the Urban Local Bodies in the State under various schemes including good will auction to be leased out by conducting public auction among the Self Help Groups without the normal channel of public auction and the provisions of Rule 12(1) (h) of the A.P. Municipalities (Regulation of Receipts and Expenditure) Rules, 1968.
- ii) Reservation for allotment of shop rooms to Self Help Groups shall be applicable only when there are a number of 10 shop rooms or more.
- iii) The allotment of shop rooms is applicable only to the Self Help Groups of Registered Slum Level Federations having completion of one year and having second dose of bank linkage.
- iv) The annual rent chargeable for the shop rooms to be constructed under goodwill amount auction method shall be fixed by the Municipal Council / Municipal Corporation at 10% of the market value of the land as fixed by the Registration Department under the Andhra Pradesh Revision of Market Value Guidelines Rules, 1998.

- v) The upset price for lease of each shop room by way of the goodwill amount (non-refundable amount) shall be fixed by conducting auction among the Self Help Groups only.
- vi) The Self Help Groups intending to participate in the auction shall deposit as security such sum as specified in the notice and may be exempted to file solvency certificate as prescribed in Rule 7(3)(b) of A.P. Municipalities (Regulation of Receipts and Expenditure) Rules, 1968.
- vii) The Self Help Groups may be exempted from depositing an amount equal to three monthly installments of the lease amount.

The Commissioner & Director of Municipal Administration, A.P., Hyderabad shall take further necessary action accordingly.
