- Training partner should ensure coverage of SC, ST, Minorities and PWD as per the MoA conditions.
- The Names of District Coordinators and name of MIS persons at State level may be communicated.

The provisional acceptance is for the purpose of establishing the suitable training centers. The batch wise work order will be generated from the software only after the training centers are registered & training calendar is updated by you and approved by the PD, MEPMA of respective districts and Commissioners of GVMC & VMC.
