**ORDER:**

Through the reference 1<sup>st</sup> cited, the Ministry of Housing & Urban Affairs, GoI, have issued guidelines for establishing Shelters for Urban Homeless in ULBs. Accordingly, vide reference 2<sup>nd</sup> cited the Govt. of Telangana has constituted the Project Sanctioning Committee for approval of Proposals submitted by ULBs for establishment of Shelters for Urban Homeless.

Vide reference 5<sup>th</sup> and 6<sup>th</sup> cited the SE. Projects, CZ, GHMC and Municipal Commissioner, Siddipet requested to cancel the earlier sanctions for construction of shelters at Petlaburj maternity hospital in GHMC and at Nehru Nagar in Siddipet respectively and approve the construction of Shelter for Urban Homeless in new locations at Mahaveer Hospital in GHMC and Manikanta Nagar in Siddipet. Further vide reference 7<sup>th</sup> and 8<sup>th</sup> cited, the Project Directors, MEPMA of Nalgonda and Mahabubnagar Districts have requested to sanction Operation and Maintenance cost to shelters functioning in rented buildings at Nalgonda & Mahabubnagar ULBs.

Vide reference 11<sup>th</sup> cited, the Project Sanctioning Committee (PSC) has cancelled the earlier sanctions for construction of shelters at Petlaburj Maternity Hospital in GHMC and at Nehru Nagar in Siddipet on different reasons and approved the proposals for construction of new shelters at Mahaveer Hospital in GHMC and at Manikanta Nagar in Siddipet and also Operation and Maintenance Cost of Rs. 6,00,000/- per shelter for (05) Years. The Project Sanctioning Committee has also approved release of Operation and Maintenance cost of Rs. 6,00,000/- Lakhs for each shelter functioning in rented buildings at Nalgonda and Mahabubnagar for a period of (02) Years.


Hence, revised sanction is hereby accorded for an amount of Rs.2,11,88,348/- (Rupees Two Crores Eleven Lakhs Eighty Eight Thousand Three Hundred and Forty Eight Only) including Operation and Maintenance Cost @ Rs. 6,00,000/- per annum per shelter for shelters at Mahaveer Hospital, GHMC & Manikanta Nagar, Siddipet for a period of 05 Yrs from date of operation of shelters and @ Rs. 6,00,000/- per annum per shelter for shelters functioning in rented buildings at Nalgonda & Mahabubnagar for 02 Yrs from the period 2016-17 as per the above statement to Commissioner, GHMC, Project Directors, MEPMA of Siddipet, Nalgonda & Mahabubnagar Districts from SUH Component of DAY - NULM.

Further, the Commissioner, GHMC, Hyderabad is requested to return an amount of Rs.12,13,614/- (Rupees Twelve Lakhs Thirteen Thousands Six Hundred and Fourteen Only) which was already released in excess towards construction of Shelter for Urban Homeless at Petlaburj Maternity Hospital which is cancelled by PSC now.

Accordingly, the Finance Manager, MEPMA, Hyderabad is requested to release an amount of Rs.12,00,000/- (Rupees Twelve Lakhs Only) to the Project Directors, MEPMA of Nalgonda and Mahabubnagar Districts towards Operation and Maintenance Cost @ Rs.6,00,000/- to each shelter at Nalgonda and Mahabubnagar ULBs for the period 2016-17 through e transfer to SUH accounts of respective districts from the available funds under SUH component of DAY-NULM.

Further, the Project Directors, MEPMA of Nalgonda & Mahabubnagar Districts are directed to release the funds to the Municipal Commissioners of Nalgonda & Mahabubnagar ULBs respectively towards Operation and Maintenance cost of functioning shelters and submit the Utilization Certificate for further release of funds.

The Commissioner, GHMC and Municipal Commissioner, Siddipet ULB are requested to complete the construction of shelters in newly sanctioned locations at Mahaveer Hospital in GHMC and Manikanta Nagar in Siddipet respectively and operationalize the shelters at the earliest as per norms of SUH component under DAY-NULM and submit the Utilization Certificate for further release of funds.
