**ORDER:**

The Project Sanctioning Committee (PSC) vide reference 1<sup>st</sup> cited has approved proposals for Construction / Refurbishment and Operation & Maintenance (O&M) Cost to Shelters for Urban Homeless in various ULBs. Accordingly, the Mission Director, MEPMA vide ref 2<sup>nd</sup> and 3<sup>rd</sup> cited has released funds towards Construction/ Refurbishment and O&M cost to shelters.

The Municipal Commissioners of Nizamabad Municipal Corporation, Ramagundam Municipal Corporation, Miryalaguda Municipality has informed that the Construction/ Refurbishment works of Shelter for Urban Homeless are under progress and submitted the utilization certificate for the amount released (1<sup>st</sup> instalment), and requested to release 2<sup>nd</sup> instalment (40% of total project cost for construction / refurbishment).

The Municipal Commissioner, Siddipet Municipality has informed that out of 2 shelters sanctioned in Siddipet (i.e. at Govt. Area Hospital and at Manikanta Nagar), the construction of shelter at Govt. Area Hospital is completed and shelter is functional and the construction of shelter at Manikanta Nagar is under progress. Further, the MC, Siddipet has submitted the utilization certificate for the amount released (1<sup>st</sup> instalment), and requested to release 2<sup>nd</sup> and 3<sup>rd</sup> instalments (40%+20% of total project cost) for both the shelters.

In this regard, out of 2 shelters sanctioned in Siddipet, as the construction of shelter at Govt. Area Hospital is completed and shelter is functional, balance 60% of the Total Project Cost for construction and Operation and Maintenance cost for 1<sup>st</sup> year is hereby released. And as the construction of shelter at Manikanta Nagar is under progress, only 2<sup>nd</sup> instalment (40% of total project cost for construction) is hereby released.

Further, the Commissioner & Project Director, MEPMA, Suryapet vide reference 11<sup>th</sup> cited, has submitted the Utilization Certificate for the Operation and Maintenance which was already released for the shelter functioning at Ganesh Nagar Community Hall, Suryapet and requested to release Operation and Maintenance cost for further period (2<sup>nd</sup> Year).

Hence, sanction is hereby accorded for release of Rs. 1,65,22,000/- (Rupees One Crore Sixty Five Lakhs and Twenty Two Thousands Only) to the Project Director & Commissioner, MEPMA of Nizamabad, Nalgonda, Siddipet, Suryapet and Peddapalli Districts as mentioned in Table-2 towards Construction / Refurbishment of Shelters and Operation & Maintenance cost to Shelters from Shelter for Urban Homeless (SUH) Component of DAY - NULM.

Further, Project Director & Commissioner, MEPMA of Nizamabad, Nalgonda, Siddipet, Suryapet and Peddapalli Districts are hereby directed to release the above funds to the Municipal Commissioners of Nizamabad, Miryalaguda, Siddipet, Suryapet and Ramagundam ULBs as shown at Table-2 towards Construction / Refurbishment of Shelters and Operation & Maintenance to Shelters as per guidelines of SUH component under DAY-NULM and submit the Utilization Certificate for release of further instalments.

The Finance Manager, MEPMA is hereby directed to release an amount of Rs. 1,65,22,000/- (Rupees One Crore Sixty Five Lakhs and Twenty Two Thousands Only) to the Project Director & Commissioner, MEPMA of Nizamabad, Nalgonda, Siddipet, Suryapet and Peddapalli Districts through e transfer as mentioned in Table -2 from the available funds under SUH component of DAY-NULM.
