Ref:- Instruction of the Mission Director, MEPMA during the review meeting held on 12.07.2018.

The Mission Director, MEPMA vide reference cited has reviewed the progress of all MEPMA activities. During the review meeting it was noticed that the state level status of Aadhar seeding of SHG members is 75.36%, the updation of remaining SHG members is lagging due to Defunct, Duplicate, Zero member SHGs etc. In this regard the SMCs and Officers in MEPMA Head Office are instructed to obtain the details of all the Defunct, Duplicate, Zero member SHGs etc by coordinating with concerned bankers and by conducting meetings with concerned SLFs and TLFs and also to monitor the progress of all activities of MEPMA in concerned Districts.

It is permitted to engage vehicles for the above officers / SMCs to visit DPMUs and ULBs. The G1 Section Assistant, MEPMA, HO shall provide hire vehicles to the above Officers / SMCs mentioned above for visiting the DPMUs and ULBs.

The Project Directors, MEPMA and Municipal Commissioners of all ULBs are requested to provide all necessary arrangements to the concerned Officers / SMCs during their visit to ULBs / DPMUs.

Any slackness in the matter will be viewed seriously and suitable action will be initiated against them. This order will supersede all the earlier orders.
