1. Telangana Municipal Laws (Amendment) Act, 2018 enacted by the Legislature of the State of Telangana.
2. G.O.Ms.No.93, MA & UD (MA) Department Dated: 18.04.2018

ORDER:

In the reference 1st read above, new Municipalities were constituted vide Act No.4 of 2018, which will come into force after completion of the term of the elected body.

2. As per Section 74 of Telangana Municipalities Act, 1965; Government may appoint Municipal Commissioners to the newly constituted Municipalities.
3. Accordingly, in-charge Municipal Commissioners are hereby appointed to the Municipalities, after expiry of the term of Gram Panchayats **annexed** to this order.
4. After assumption of the charge, the Municipal Commissioner shall take immediate action on the following points.
 - i. Seize the minutes book, building permission registers, mutation registers, door numbering registers, stock registers, record room etc. of the erstwhile Gram Panchayats and keep it in safe custody.
 - ii. To open a new bank Account in the name of the Municipality.
 - iii. To take over cash books under all schemes and unused cheque books and close the existing bank accounts and transfer the funds into the new Account of the Municipality and maintain separate cash book for incurring expenditure under the above funds.
 - iv. To erect the name board of Municipality on the office building and other places wherever required.
 - v. To furnish the information about the erstwhile Gram Panchayat in the prescribed format I to IX for taking further action in the matter.
5. The Municipal Commissioners are informed that if any court orders are existing on constitution of new Municipality, the orders of the Hon'ble High Court shall be complied and same may be brought to the notice of the Government and CDMA immediately.
