I invite attention of all the Project Directors in the state to the subject cited and inform that as part of the Shehri Samrudhi Utsav 2019 activities under Social Mobilization & Institution Development (SM & ID) Component of DAY-NULM, MEPMA, Telangana to catalyze the formation of SHGs and their federations and to promote the Financial Inclusion of SHG members under DAY-NULM.

Accordingly it decided to identify the Tot IB CRPs, among the SLF RPs to deploy in other ULBs and existing to catalyze the formation of SHGs revival of default SHGs and their federations and to promote the Financial Inclusion of SHG members under DAY-NULM.

Criteria for Identification of Tot IB CRPs for strengthening of CBOs

- She should be SLF Resource person (RP)
- She should be SHG member with 5 years seniority
- Trained in IB CRPs / good communication in Telugu and local language
- Age limit 25 to 45 years age
- Physically fit without any Health Chronic Aliments
- IB CRPs shall not belong to any political party and shall not be the spouse of any political executive.
- IB CRPs shall have the capacity to analyze the local issues and act accordingly and timely for poor community for SHG strengthening.
- Willing to travel to other ULBs for SHG strengthening revival of SLFs

Selection Process:

- IB CRP Tot selection, preferably, should be done in monthly meetings of the concerned TLFs in exceptional case in exclusive TLF meetings and get the resolution by the Town Level Federations of final list of IB CRPs.
- COs/TMCs and other staff should not involve in the process of selection

Accordingly conduct the meeting with TOT CRPs at town level and make a Action plan on revival of default groups and new SHG group formation including vulnerable groups in Pakwada period and also prepare them for training on this subject.

Hence all the Project Directors, MEPMA and UCD GHMC are directed to adhere the guidelines and Complete the process and submit the list of Tot CRP list 10 per the ULB by 2nd February 2019 to Head Office.
