The Skill Training Provider shall commence the trainings within a period of 7 (Seven) working days from the receipt of work order. The training centers should be owned/leased/rented by the STP, the faculty should be on the pay rolls of the STP and ToT should be provided regularly and minimum wages to be provided to the candidates provided placements.

The above physical targets are tentative and subject to change as per the online updating of training centers and training calendar. The review will be done after the completion of the training and placements to evaluate overall performance. Additional target may be given after examining the performance of STP in training & placements. MEPMA reserves the right to decrease or increase the targets as per the performance.
