- Infrastructure is not as per the guidelines of MoA /NSQF.
- Not providing the placements to at least 70% of youth as per inception of any batch.
- Non updation of performance in DAY-NULM and MEPMA portals.

Regular reviews will be conducted to evaluate overall performance. Additional target may be given after examining the performance of STP in training & placements. MEPMA reserves the right to decrease or increase the targets as per the performance of STP.
