With reference to the 4th cited as per the guidelines of DAY-NULM MoHUA, Government of India, Ministry has advised the states in implementing the Shelter for Urban Homeless (SUH) to develop the two model shelters one in the capital city and another in a big city. These shelter will act as "proofs of concept" showcasing the mandated facilities for urban homeless it has been used for the quality of care and services to the urban homeless.

With reference to the 3rd cited, as per the Minutes of the SLSMC meeting that Commissioner GHMC ,GWMC shall identify the suitable sites for constructing for model shelters as per the NULM (Model shelter) guidelines and to submit with Detailed Project Report (DPRs) with estimations to the Project Sanction Committee (PSC) SUH, MEPMA for approval .

In view of the above, the Commissioner, GHMC and the Commissioner GWMC are requested to identify the open land/unused building for new construction or refurbishment for development of one model shelter each in GHMC area and GWMC area as per operational guidelines of SUH and submit the list of locations identified within one week to MEPMA Head Office for further necessary action.
