Sub: MEPMA – DAY-NULM – Support to Urban Street Vendors (SUSV) – Preparation of City Street Vending Plans in all 74 ULBs (Old) – Timelines - Regarding.

I invite your attention to the subject cited, as per the Chapter VI, Section 21 of The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 (Central Act 7 of 2014), every local authority shall, in consultation with the planning authority and on the recommendations of the Town Vending Committee, once in every five years, prepare a plan to promote the vocation of street vendors.

Further, during the review meeting held on 16.11.2019 you have been instructed to prepare the City Street Vending Plans in all 74 ULBs (Old) on or before 28.11.2019 where survey of Street Vendors is done. Accordingly, orientation was given to PDs and DMCs of all Districts on tool kit for preparation of City Street Vending Plans.

The following are the series of activities to be taken up for preparation of City Street Vending Plans in each ULB.

1. Organize meeting in all ULBs with Municipal officials (Town planning, Engineering, MEPMA etc) and TVC members by 20.11.2019.
2. Resurvey of Street Vendors in the ULBs (if required)
3. Demarcation of vending zones and site inspection of the zones by Town Planning, Engineering, MEPMA staff to cross check the feasibility of vending by 22.11.2019
4. Preparation of vending zone map and calculation of vending carrying capacity with town planning staff by 25.11.2019.
5. Conduct TVC meeting to take feedback on the draft CSVP by 27.11.2019
6. Finalization of vending plan and submission to Head office by 28.11.2019

Hence, the Additional Commissioner, UCD, GHMC and Project Directors, MEPMA of all the Districts and Municipal Commissioners of concerned ULBs are hereby instructed to prepare City Street Vending Plans in the concerned ULBs within timelines as mentioned

above duly following the guidelines of DAY-NULM and The Street Vendors Act 2014.
