I invite your attention to the references cited, the Ministry of Health and Family Welfare has planned to organize National Wide Polio Immunization Vaccination Campaign on 19th January 2020. And mention that the last case of Polio in India was reported on 13th January 2011. Though wild polio cases are being reported globally from only two neighboring countries but India continues to maintain polio free status. This has been made possible due to sensitive polio surveillance with quality pulse polio rounds to maintain population immunity. The Ministries of the Central Government, State Governments, partners and other stake holders have worked together to ensure that the country maintain population immunity by observing quality pulse polio rounds thereby helping the country to remain polio free.

In the last three years, the world is seeing a surge in polio cases in two polio-endemic countries and they happen to be in our immediate Neighborhood, In 2019 (till 37 Nov), 112 wild polio virus cases have been reported has compared to 33 cases for entire period of 2018. Hence, there is no room for complacency.

To mitigate the risk, the India Expert Advisory Group on Polio eradication has recommended intensive polio vaccination campaigns until the virus is interrupted globally.

In this subject it is proposed by Government of India that to ensure the adequate numbers of polio Vaccination booths to be set up in the slum areas and special efforts are made by involving the community Based Organizations (CBOs) of SLFs, TLFs , NGOs ,Youth and students for mobilizing the families to the immunization Booths on the 19th January 2020.

In this subject the Following activities to be taken up in the ULBs for mobilization of Pulse Polio Campaign of your districts:

1. To identify the uncovered/ vulnerable areas of slums to set up the Polio Vaccination Booths and submit the report in the prescribed format
2. To facilitate the information in all the SHG/ SLF /TLF meetings on Mobilizing the families to the immunization booths on 19th January 2020
3. To ensure active participation of CO, TMCs and DMCs of MEPMA staff in mobilization of families to the immunization booths on 19th JANUARY 2020 i.e on this day it will be working day to the MEPMA staff for monitoring the mobilization campaign .

In this regard, the Addl. Commissioner UCD GHMC and all the Project Directors , MEPMA are instructed to ensure that adequate numbers of Polio Vaccination booths are to be set up in the Slum Areas and special efforts are to be made for conducting special SLF and TLF meetings on health agenda of polio vaccination on above date and facilitation of the children to booth centres and also requested to involve the MEPMA staff , NGOs, Youth and Student in mobilization of the families to the Pulse Polio Immunization Day on the 19th January 2020.
