
With reference to the subject cited and in compliance to the instructions vide references mentioned above and inform that Solid Waste Management which includes source segregation of wet and dry waste, door to door collection, establishment of Dry Resource Collection Centre and composting of wet waste to manure etc. Better sanitation practices will lead to better health conditions.

Accordingly, a month long Swatchta campaign is proposed from 16th March, 2020 to 15th April, 2020 involving the existing Resource Persons of MEPMA the following activities must be taken up:

1. Door to Door awareness campaign by RPs by involving SLF/SHG members for source segregation of wet and dry waste and door to door collection.
2. Establishing Dry Resource Collection Centers (DRCCs) & Community Composting/home composting pits.
3. Arrangement of separate compartments/bins for dry/wet waste in all vehicles shall be made available
4. Vermi composting of wet waste at houshold/ Community Compost yard and dry waste to be transported to DRCC for further processing.
5. Separate collection of commercial waste, market waste, hotels and drains silt shall be done to increase the segregation

In this regard, the RPs will actively participate in the campaign with support and participation of SHGs/SLFs.

Therefore, it is requested to take up Swatchta Campaign with an emphasis on source segregation as part of the Community Managed system of Solid Waste Management and achieve 100% segregation.
