I invite your kind attention to the subject cited that the Shelter For Urban Homeless
component under DAY-NULM is directly monitored by Supreme Court.

As per the guidelines under this component the following activities under SUH to be
monitored by the Project Director, MEPMA as below.

- As per the timeline sanctioned shelters to be constructed .
- Time to time survey of Urban Homeless.
- Mapping of shelters nearby colleges.
- Mapping of other than DAY-NULM shelters working for Urban homes.
- Providing entitlements to the shelter residents of DAY- NULM shelters as well as other than DAY-NULM shelters.
- After five years O & M funds will not be released by DAY-NULM scheme it can be accommodated by the ULB finances.
- As per the supreme court guidelines under Shelter for Urban Homeless (SUH) of DAY-NULM all sanctioned shelters to be functioned as per the timeline period.

In this regard it is noticed that as per the State Project Sanction Committee (PSC) report total 50 shelters are sanctioned out of 31 shelters are functioning where 8 shelters are newly sanctioned in 2019-20 financial year and 12 shelters are not yet functioning in 12 Districts including GHMC .
