Attention to the subject cited, as per the provisions of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 and as per the guidelines under SUSV component of DAY-NULM, the Town Vending Committee (TVC) shall conduct a survey of all existing Street Vendors and every Street Vendor identified shall be issued a Certificate of Vending and Identity Card by the TVC.
