Sub: MEPMA -Telanganaku Harithaharam - Development of Homestead Nurseries in Municipalities – certain instructions – Issued –Reg.

3. Instructions issued in Video conference held on 17.06.2020 by Director of Municipal Administration.

The attention of the Municipal Commissioners in the State is invited to the references cited wherein instructions are issued regarding preparatory work for taking up of Pattana Haritha Haram – TKHH 2020 which is a Flagship Programme of the State.

The Director, Municipal Administration and Mission Director, MEPMA during the video conference held on 17.06.2020 has given the following instructions on raising of Homestead Nurseries by SHGs/ALFs/TLFs in all ULBs during Haritha Haram Programme:

1. The Municipal Commissioner shall identify SHGs/ALFs/TLFs who have experience/interest in developing homestead nurseries and to establish homestead nurseries as per the targets.
2. The homestead nurseries may be established in the land available in the premises of the SHG members or Municipal Commissioner should allot available open space/parks/ Mpl lands/ Govt lands to SHGs/ALFs/TLFs with proper fencing and water supply.

3. The SHGs/ALFs/TLFs shall bear the cost of the seedlings and take care of the plant until it grows to minimum 2 feet height. It shall be the responsibility of the SHGs/ALFs/TLFs for nurturing the Plant.
4. Required support may be provided in procuring soil and compost to the SHG members for the development of nurseries.
5. SHGs can raise the Fruit bearing, Flower shrubs, medicinal plants and Mosquito repellent plants in these homestead nurseries.
6. An agreement may be entered by the Municipal Commissioner concerned and work order may be issued to the selected SHG/ALF/TLF.
7. The healthy plant shall be taken by the Municipal Commissioners @ Rs. 10.00 per each Healthy plant following due procedures. (Maintaining stock register, Distribution format with signatures, documentation with photographs etc.,) Same shall be met from the Green Budget of ULBs.
8. If the SHG member is unable to put the initial capital cost for raising the plants, a loan may be arranged from SHG/SLF/TLF by coordinating with MEPMA staff.
9. The amount payable to the SHG member shall be directly transferred to the bank account of the SHG member/SHGs/ALFs/TLFs.
10. Required fibre tree guards for TKHH 2020 may also be procured from the ALFs/TLFs on the rates finalised at the Dist Level by Dist Collector.

3. Therefore, the Municipal Commissioners are hereby directed to follow the above instructions and ensure to establish homestead nurseries under TKHH 2020. Further, the Municipal Commissioners are instructed to clear the pending payments of plants received from the Homestead Nurseries raised by the SHGs/ALFs/TLFs in the year 2019-20 @Rs. 10/- per plant immediately and submit ATR.

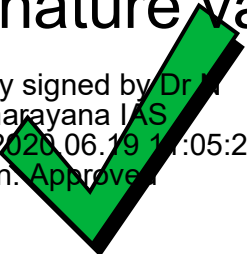
