ORDER: -

In the reference 1<sup>st</sup> read above, the Government of India have launched a new scheme namely PM Street Vendors Atma Nirbhar Nidhi for providing Special Micro – Credit Facility to Street Vendors to resume their livelihoods that have been adversely affected due to COVID-19 Lockdown. As per the guidelines of this new scheme, a State Level Monitoring Committee is to be constituted under the Chairmanship of Principal Secretary to Government, Municipal Administration and Urban Development Department.

2. Accordingly, the Government hereby constitute the following State Level Monitoring Committee for effective implementation and monitoring the progress of PM Street Vendor's Atma Nirbhara Nidhi Scheme in all Municipalities at the State.
