In the reference 1st cited the Government of India issued instructions regarding convergence plan between National Urban Health Mission (NUHM), Swachh Bharat Mission(SBM), and National Urban Livelihood Mission(NULM) to develop a holistic environment covering health sanitation and livelihood.

Accordingly MEPMA has entered into an agreement with Administrative Staff College of India (ASCI) on Gender Integration in Sanitation in Urban Telangana as per the instructions of GOI.

As per the MOU, the key outcomes over period of three years are as below,

1. Enhanced awareness among women, girls and vulnerable groups regarding the link between sanitation and health.
2. Enhanced awareness among women, girl and vulnerable groups about the importance of safe toilets, usage of toilets, regular emptying of containment systems (septic tanks/Twin pits), safe treatment of faecal

- sludge and septage.
3. Enhanced awareness among women, girls, men and boys regarding Menstrual, Hygiene Management.
 4. Enhanced representation of women in sanitation decision making processes at household, community and city level.
 5. Enhanced access to women, girls and vulnerable groups to appropriate sanitation facilities.
 6. Enhanced participation of women in delivery of sanitation services(livelihoods)
 7. Enhanced participation by women as entrepreneurs in sanitation.
 8. Enhanced budgets for women and sanitation program at city and state level.

In this regard, it is proposed to conduct the online trainings to all the TLF Presidents , TLF RPs and MEPMA ULB Staff on Gender Integration in Sanitation through Zoom app /Mega webinar by ASCI from 29th July 2020 onwards . Further mobile numbers of TLF presidents, TLF RPs and concern MEPMA ULB Staff are necessary to conduct online trainings.

Therefore the Additional Commissioner UCD GHMC and all the Project Directors of MEPMA are requested to furnish the mobile numbers of TLF Presidents , TLF RPs and MEPMA ULB Staff details on or before 28.07.2020 in the format enclosed herewith.
