I invite your attention to the subject cited.

Under DAY NULM Scheme and MEPMA, Shelter for Urban Homeless ,which is one of the important component. This scheme aims at providing permanent shelter equipped with essential services to the urban homeless in a phased manner to cover all the district headquarter towns and other towns with population of one lakh or more as per the Census of 2011.

2 Accordingly, The Project Sanction Committee of Shelter For Urban Homeless ,Government of Telangana has sanctioned the 22 new, Construction of Shelter Buildings at District Head Quarters ULBs and ULBs having sizeable population . It is proposed to take up Construction of Shelter Building with 3600 Sft. Plinth area and unit cost of Rs. 45 Lakhs for which minimum land required is 800 Sq yards ( with 110'X 60') preferably .

3. In view of above all the Municipal Commissioners in the address entry are requested to identify the land for construction of shelters by 10<sup>th</sup> September 2020 and submit the compliance through a letter indicating the boundaries of land to this office immediately.
