ORDER:

Through the reference 4th cited, sanction was accorded for conducting 5 camps in all ULBs between 16th to 31st October 2020 for sanctioning, disbursing of all loans, Digital on-boarding by issue of QR codes and training of all Street Vendors. Accordingly camps were organized, but still there are some vendors for whom sanctions and disbursements are pending.

2. Further, during the Video Conference held on 29.10.2020 the Addl. Secy, DFS, GoI and JS, MoHUA, GoI, have reviewed the Bank wise progress of PM SVANidhi with Convenor, SLBC and GMs of various banks and instructed to complete sanction and disbursement of all loans by 15th November 2020 keeping in view of Diwali festival.

3. Accordingly, it is decided to organize further camps till 15th November 2020 in all ULBs on the following dates.

4. An amount of Rs. 6,000/- (Rupees Six Thousand Only) is sanctioned for each camp in each ULB towards Logistic Arrangements (Chairs, Tables, Audio Video System, Banners, Tent (if required), etc), Drinking water, Tea and Snacks to Bankers, Payment aggregators, Trainers, other officials, Hand Sanitizers, Stationary items etc.

6. The Municipal Commissioners are instructed to organize the camps and mobilize all the Street Vendors to the camps (No. of Street vendors to be mobilized in each camp should be decided based on the total no. of the street vendors applied for PMSVANidhi in the ULB) and also ensure presence of Branch Managers of all Banks, RM/ Managers/ Asst Managers of Streenidhi and representatives of digital payment aggregators like Pay Swift, Phone Pay, Paytm, Airtel Payment Bank etc for taking up the following activities in the camps duly following the COVID-19 Protocol:

- a. Coordinate with bankers for sanction and disbursement of all the pending applications under PMSVANidhi and update in Udyamimitra Portal.
- b. To coordinate with Bankers and Digital payment Aggregators for generation of UPI IDs and issue of digital QR Codes to Street Vendors in the camps.
- c. All the Street vendors who have been sanctioned loans should be trained in digital transactions by using QR code and payment App/ BHIM UPI App and financial literacy by utilizing the services of local bank branches and Digital Payment aggregators.
- d. Issue of RuPay debit card to the Street Vendors who don't have ATM card.
- e. Make the Street Vendors to undertake the penny drop transactions for both the processes – Credit & Debit, to create evidence for handholding.

7. Hence sanction is hereby accorded for an amount of Rs. 35,04,000.00 (Rupees Thirty Five Lakhs Four Thousand Only) for conducting 4 camps in each ULB and 4 camps in each Zone of GHMC.

8. Accordingly, the Finance Manager, MEPMA is hereby requested to release an amount of Rs. 35,04,000.00 (Rupees Thirty Five Lakhs Four Thousand Only) to the Project Directors, MEPMA as per the above statement through e transfer to respective districts from the available funds under NULM funds.

9. Further, the Project Directors, MEPMA are directed to release the funds to the concerned Municipal Commissioners towards conduct of Camps for Sanction, Disbursement of loans, Digital on-boarding of Street Vendors and Training on digital transactions and submit the Utilization Certificate to the under signed.

10. Hence, the Commissioner, GHMC, CEO, Secunderabad Cantonment Board and the Municipal Commissioners of all ULBs are requested to organize the camps on the above said dates and ensure sanction, disbursement of all loans, Digital on-boarding and training of all

Street Vendors for whom loans are sanctioned under PMSVANidhi Scheme.
