International Day of Persons with Disabilities is annually observed on 3rd December with an objective to promote an awareness of disability issues, the fundamental rights of persons with disabilities and integration of persons with disabilities in the main stream of each aspect of the social, political, economic and cultural status of their communities. The day extends an opportunity to initialize action to reach the target of full and equal pleasure of human rights and contribution in society by disabled persons.

On December 3rd 2020 , during the annual celebration of people with disabilities, this year theme is 'Not all Disabilities are Visible' also focuses on spreading awareness and understanding of disabilities that are not immediately apparent, such as mental illness, chronic pain or fatigue, sight or hearing impairments, diabetes, brain injuries, neurological disorders, learning differences and cognitive dysfunctions, among others.

According to the WHO World Report on Disability, 15 per cent of the world's population, or more than 1 billion people, are living with disability. Of this number, it's estimated 450 million are living with a mental or neurological condition— and two-thirds of these people will not seek professional medical help, largely due to stigma, discrimination and neglect.
