- Sub: MEPMA Abhayahastham Verification of enrolled member's eligibility for sanction of Abhayahastham Pensions from OCT '2014 to May '2016 Reg.
- Ref: Lr.No. TS/09/SERP/SSU/ABH Pensions/2014, Dated: 06.07.2016 from the Chief Executive Officer, SERP.

I invite your attention to subject cited. In the reference cited, the CEO, SERP has informed that as per the guidelines of the Abhayahastham scheme, the SHG member is eligible to get pension @ Rs.500/- pm after completion of 60 years of age and it is proposed to sanction pension to the enrolled members who crossed 60 years of age from Oct '2014 to May '2016.

In this regard, the District wise No. of eligible pensions is herewith attached for necessary action and to give necessary instructions to the concerned staff (ADMC-SS) to verify the member eligibility for the sanction of pension under Abhayahastham Scheme as per the rules and G.Os. The verification officers shall follow the following criteria to verify the member's eligibility and fill the prescribed format:

- The member must have one year regular and active membership in Self Help Group at the time of enrollment into the scheme, i.e. 1st Nov'2009. The SHG books of accounts i.e., Minutes book, SHG Pass book shall be verified to ensure the attendance and members savings.
- Age of the member shall be verified with the age proof submitted by the member at the time of enrolment i.e., Food Security Card/EPIC card/Birth certificate/School certificate/Voter list.
- After verification of data, the verification officer shall upload the eligibility of the members in website.

Therefore, the Project Directors are instructed to complete the verification process and upload in website before 20.07.2016 for sanction of pension @ Rs. 500/- pm under Abhayahastham Scheme to the eligible members.
