**ORDER:**

Through the ref. 1<sup>st</sup> cited, the Chairman, TSFPS, GoTS has released Seed Capital of Rs.7,20,000/- through PFMS under PMFME Scheme pertaining to Miryalaguda ULB for 18 enterprises with 18 beneficiaries performing food processing.

2. Steps to be followed in Implementation of Seed Capital under PMFME Scheme are as follows:
  - ALF to disburse sanctioned amount to Enterprises bank account within 2 weeks through RTGS/NEFT
  - SHGs and ALFs shall maintain a separate ledger for the loan released as Seed Capital and upload on PMFME MIS
  - The quantum of rate of interest on seed capital can be decided by the respective ALFs, but it should not exceed 6 % per annum. Of this, 3% shall be retained by SHGs towards management of loans.
  - TMCs / COs to support the SHGs for calculating the EMI schedule of each beneficiary
  - ALFs shall recover the EMI through SHGs.
  - Month wise repayment details of all beneficiaries shall be obtained by concerned ALFs and shall be monitored by ULBs.
  - A separate agenda point shall be included in ALF and SHG meetings for accessing the repayment of Seed Capital loan.
3. In view of the above, sanction is hereby accorded for release of Rs.7,20,000/- (Rupees Seven Lakhs Twenty Thousand Only) as Grant-in-aid to 12 ALFs (list enclosed) towards Seed Capital assistance under PMFME Scheme.
4. Hence, The Finance Manager MEPMA, is directed to release an amount Rs.7,20,000/- through RTGS/NEFT towards Seed Capital to 12 ALFs under PMFME Scheme.
