ORDER:

Through the reference 1st cited, the Ministry of Housing & Urban Poverty Alleviation, Govt of India has issued guidelines for establishing the Shelters for Urban Homeless in NULM Towns.

Through the reference 3rd and 4th cited, proposals have been received from the Municipal Commissioner, Ramagundam Municipal Corporation and District Collector, Nizamabad District, for construction of three new shelters and one new shelter respectively and approved by the Project Sanctioning Committee vide ref. 5th cited. The details are as follows:

Hence, sanction is hereby accorded for release of Rs. 52,80,000.00 (Rupees Fifty two Lakhs Eighty Thousand only) to the Project Director, MEPMA, Karimnagar District and Rs.22,00,000.00 (Rupees Twenty two lakhs only) to the Project Director, MEPMA, Nizamabad District towards 1st instalment of 40% of total project cost for construction of shelters for urban homeless in Ramagundam and Nizamabad Municipal Corporation.

Further, the Project Director, MEPMA, Karimnagar District is directed to release the funds to the Municipal Commissioner, Ramagundam Municipal Corporation and the Project Director, MEPMA, Nizamabad District is directed to release the funds to the Municipal Commissioner, Nizamabad Municipal Corporation for taking up construction activity of proposed shelters at Ramagundam and Nizamabad respectively as per norms of SUH component under NULM and submit the Utilization Certificate for release of further instalments.

The Finance Manager, MEPMA is directed to release an amount of Rs. 52,80,000.00 (Rupees Fifty two Lakhs Eighty Thousand only) to the Project Director, MEPMA, Karimnagar District and an amount of Rs.22,00,000.00 (Rupees Twenty two lakhs only) to the Project Director, MEPMA, Nizamabad District through e transfer from the available funds under SUH component of NULM.
