## **ORDER:**

Vide reference 1<sup>st</sup> cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all ULBs of NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services to the urban poor.

In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments may be as follows

- > 1<sup>st</sup> insta1lment 30% released by SULM to ULB within one week of the proposal, sanction order is approved.
- ≥ 2<sup>nd</sup> Installment 40% after the staff of CLC is recruited.
- ➤ 3<sup>rd</sup> Installment 30% will be released offer launch of CLCs.

In reference  $2^{nd}$  cited, the Project Director, Nizamabad district is requested to release  $2^{nd}$  installment 40% funds i.e., an amount of Rs.4.00 Lakhs 1 CLC towards staffing and other miscellaneous expenditure for running of CLCs.

In the reference 3<sup>rd</sup> cited, the Project Director, Nizamabad district submitted the ratification for the relocation of CLC center in the Nizamabad district.

Therefore the CLC at IDP colony, New NGOs Colony, Nizamabad has been shifted to the New Housing Board Colony, Vinayaknagar, Nizamabad as per the instructions of the Commissioner, Municipal Corporation, Nizamabad for effective functioning of the centre.

In the 3<sup>rd</sup> cited 1<sup>st</sup> installment funds were released to Nizamabad ULB Rs 6 Lakhs for two CLCs (Each Rs 3 Lakhs per CLC) in locations of Goutham Nagar ,Near Water tank, and another in IDP colony Near NGOs.

In this regard, the 2<sup>nd</sup> installment 40% funds will be released after the staff of CLC is recruited and therefore the staff is recruited in 1 CLC building which is located at Vinayaknagar, Div No.6, Nizamabad district the fund towards staffing and other miscellaneous expenditure for running of CLCs is releasing an amount of Rs. 4.00 Lakhs for 1 CLCs and another CLCs which is located at Gouthamnagar, New water tank is released after sending the detail report on grounded of CLC.
