

**Minutes of the review meeting held on 12-08-2015

The Mission Director, MEPMA has reviewed the Action Taken Report on the decisions taken on the Staff review meeting held on 12-08-2015 with the MEPMA staff and representatives of CGG, TCS and APITCO and given following directions.

Bank Linkage

- To release VLR for 2 months i.e., April 2014 & May 2014 to all eligible SHGs of all districts.
- To release Interest Subvention for April 2015 to June 2015 to all eligible SHGs in all NULM Towns
- DO letter to all Collectors to review Bank Linkage, VLR & Interest subvention issues at monthly intervals.

Action to be taken – SMC- BL, TCS, PM CGG

Employment through Skill Training & Placement (EST&P) :

- To furnish placement details STP wise

Action to be taken – SMC- EST&P, TCS, PM CGG

Street Vendors

- DO letter to Commissioner, GHMC through Principal Secretary on progress of street vending activities, etc.,
- New proposals to be obtained from ULBs on street vendor markets .
- To speed up survey of street vendors , issues of ID cards and vending certificates in NULM towns .

Shelter for Urban Home Less (SUH) :

- Online format approved by MD MEPMA has to be updated in MEPMA website for online updation .
- To add sub columns in SUH in dash board
- Revised the targets of SUH based on the practical potential
- The information regarding availability of Shelter in Major Hospitals to be furnished.
- Planned for establishment of new shelters has per the targets.

SEP:

- Presently drive programme at GHMC on Swatchh Driver cum Owner is to be linked under SEP and interest subvention adjusted to the loan account.
- Applications to be uploaded in MEPMA website as per NULM guidelines.

Social Mobilization And Institutional Building

- Workshop on Swatchh Bharat to DMC-IB, TMC ,Cos of all towns at CDMA Conference Hall in next week to be organized for fixing targets .
- To speed up the updation of Member data, SHG, SLF,TLF data, it is decided to release the Rs 15 per SHG (Rs 5 Collection , Rs 10 per Data entry) in all NULM towns . Funds may be utilized from IEC Component.
- DO letter to GHMC Commissioner to address on all NULM Components through Principal Secretary, MA & UD Dept
- Resource Organization may be selected for Social Mobilization and Institutional Building activities in GHMC .
- In GHMC 18 circles CLCs are to be grounded in this financial year . And sanctioned CLCs are to be updated in MEPMA website .

MIS :

- To analyze Bank Linkage achievement Bank wise and provide online report on the same.
- To calculate Vaddi Leni Runalu and Interest Subvention for May and June'2015 and place in the reports.
- To share one ULB data to NULM NIC team for migration of data into NULM MIS by 14.08.2015.
- Directed to complete the Online grievance/ Issues monitoring system.
- To update data of dash board by TCS- Streenidhi, Social Security and CGG- Street vendors information.
- To send mail to Bankers regarding Community Organizer signature is not mandatory to sanction loans to Self Help Groups.

Streenidhi :

- Loans availed under Streenidhi for grounding of Livelihood units is updated in SEP progress . And release the interest subvention for eligible members. ^{to be}

- Process the file for sanction of Additional post of Community Organizers (COs) as per NULM guidelines to the government.
- CBT training to COs of GHMC at MCRHRD to be organized in September Month .
