ORDER:

Through the reference ref 4th & 5th cited, sanction was accorded for conducting 9 camps in all ULBs between 16th October to 13th November 2020 for sanctioning, disbursing of all loans, Digital on-boarding of Street Vendors by issue of QR codes and training of all Street Vendors. Accordingly camps were organized, but still there are some vendors for whom sanctions and disbursements are pending.

2. Further, during the meeting held on 05.11.2020 with the CGM, SBI and CGM, UBI (Major Banks) and SLBC meeting on 09.11.2020, it was requested by the bankers to conduct Bank/ Branch wise Camps in ULBs for completing the pending sanctions and disbursements of all loans under PMSVANidhi.

3. Accordingly, it is decided to organize further Bank/ Branch wise camps during November 2020 in all ULBs based on the requirement and request of the bankers.

4. An amount of Rs. 1,500/- (Rupees One Thousand Five Hundred Only) is fixed for each

camp towards Logistic Arrangements [Chairs, Tables, Tent (if required), Drinking water, Stationary items, Misc, etc.]

5. The Municipal Commissioners of all ULBs are hereby instructed to coordinate with bankers with more pendency of sanctions and disbursements and organize bank/ branch wise camps. Minimum of 150 Street Vendors to be mobilized in each camp. The following activities are to be taken up in each camp duly following the COVID-19 Protocol:

- a. Sanction and disbursement of all the pending applications under PMSVANidhi and update in Udyamimitra Portal.
- b. Generation of UPI IDs and issue of digital QR Codes to Street Vendors in the camps.
- c. Training Street Vendors in digital transactions by using QR code and payment App/ BHIM UPI App and financial literacy by utilizing the services of local bank branches and Digital Payment aggregators.
- d. Issue of RuPay debit card to the Street Vendors who don't have ATM card.
- e. Make the Street Vendors to undertake the penny drop transactions for both the processes Credit & Debit, to create evidence for handholding.

6. Hence sanction is hereby accorded for an amount of Rs. 1,500/- (Rupees One Thousand Five Hundred only) towards conduct of each Bank/ Branch wise camp. The expenditure shall be met from Municipal General Funds or balance unspent funds available if any, which are already released for earlier camps. The balance amount spent shall be reimbursed to ULBs on submission of camp wise report to MEPMA Head Office in Format.SVSD enclosed.

7. The Municipal Commissioners of all ULBs are hereby instructed to organize bank/ branch wise camps based on the requirement and request from the bankers and ensure sanction, disbursement of all loans, Digital on-boarding and training of all Street Vendors under PMSVANidhi Scheme. The camp wise details shall be submitted to undersigned without fail.
