**ORDER:**

In view of the above, the Project Directors, DPMU-MEPMA are requested to pay the honorarium to the Resource Persons through Slum Level Federation / Town Level Federation / Town Vikalangula Samakhyas after due verification on the basis of work done report, attendance and Resolution of the concerned SLFs, TLFs & TVSs duly certify the Municipal Commissioners of concerned Municipalities/Corporations. Any deviation in the manner prescribed above towards the payment of Honorarium of Resource Persons the Municipal Commissioner will be held responsible and action shall be initiated.

The expenditure shall be met from available funds released by the Government under Assistance to Municipalities /Corporations for interest free loans (Vaddileni Runalu).
