The details of loans disbursed and repayment made under SHG-Bank Linkage were updated in MEPMA Portal by the field staff for Non data sharing banks on monthly basis. In respect of Data sharing banks the loans will be automatically mapped to the SHGs based on SB account from the data shared by banks.

The NULM amount has been calculated by Technical Service Provider (TCS) for the eligible SHGs having regular repayment, SHGs having complete (Women–10; PWD-5) members and SHGs which have completed Aadhaar Seeding for the period April 2019 to March 2020.

The Data of eligible SHGs is herewith attached for verification at ULB/district level. The Project Directors are directed to verify the data of SHGs for the following:

- Whether the SHG is eligible for interest subvention as per the NULM norms.
- Verification of duplicate SHGs if any.
- Whether VLR received from SERP, for the SHG migrated from Rural. (New Nagarpanchayts)
- Whether the SHGs SB account is closed.
- Whether the group is inactive.
- Update the details of SB accounts of SHG if any difference in SB account correction screen.
- When there are multiple loans to a single SHG, verify each loan for eligible under NIILM
- Verify with concerned bank and record the documents certified by Bank, CO, TMC etc., for audit purpose and submit the same to head office.
