ORDER:

Vide reference 1st cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services to the urban poor.


In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments are as follows:

- 1st installment (30%) of the total cost will be released by SULM to ULB within one week of the proposal, sanction order is approved
- 2nd Installment 40% of the project cost will be released after the staff of CLC is recruited
- 3rd Installment 30% will be released after launch of CLCs.

Vide reference 2nd & 3rd cited, the proposals received from Nizamabad & Warangal districts for NULM towns have been examined and recommended for the release of 1st Installment of 30% i.e an amount of Rs. 3,00,000/- to each City Livelihoods Centers (CLCs) in Nizamabad & Warangal districts.

The Project Director, Nizamabad district are requested to meet the expenditure of Rs. 6,00,000/-(Rupees. Six Lakhs Only) towards establishment of 2 City Livelihoods Centers (CLCs) from the available funds of SM & ID component of NULM funds.

The Project Director, Greater Warangal Municipal Corporation, Warangal district are requested to meet the expenditure of Rs. 9,00,000/-(Rupees. Nine Lakhs Only) towards establishment of 3 City Livelihoods Centers (CLCs) from the available funds of SM & ID component of NULM funds.
