ORDER:

Through the reference 1st cited, the Ministry of Housing & Urban Poverty Alleviation, Govt of India has issued guidelines for establishing the Shelters for Urban Homeless in NULM Towns.

The Project Sanctioning Committee vide reference 3rd cited has approved proposal for Refurbishment of Old School Building at Kattarampur in Karimnagar for establishment of Shelter for Urban Homeless with total project cost of Rs. 23.00 Lakhs. Accordingly, the Mission Director, MEPMA vide ref 4th cited has released an amount of Rs. 9.20 Lakhs towards 1st Instalment (40% of total project cost).

Further, the Municipal Commissioner, Karimnagar Corporation has takenup the refurbishment works at Old School Building, Kattarampur and submitted the Utilization Certificate to the funds already released. Further, the Project Director, MEPMA Karimnagar District vide ref 6th cited has requested for further release of balance funds towards refurbishment works.

Hence, sanction is hereby accorded for release of Rs. 9,20,000/- (Rupees Nine Lakhs Twenty Thousand only) to the Project Director, MEPMA, Karimnagar District towards 2nd

instalment (40% of total project cost) for Refurbishment of Shelter for Urban Homeless at Old School Building, Kattarampur, Karimnagar from SUH Component of DAY - NULM.

Further, the Project Director, MEPMA, Karimnagar District is directed to release the funds to Municipal Commissioner, Karimnagar Municipal Corporation and submit the Utilization Certificate for further release of balance funds (3rd instalment).

The Finance Manager, MEPMA is directed to release an amount of Rs. 9,20,000.00 (Rupees Nine Lakhs Twenty Thousand only) to the Project Director, MEPMA, Karimnagar District through e transfer from the available funds under SUH component of DAY-NULM.
