I invite your attention to the subject cited and it is to inform that, under section 22 of the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014 the Town Vending Committee (TVC) has to be constituted by the concerned Urban Local Body (ULB).

Further, in excise of the powers conferred under Sub section (1) of Section 38, of The Street Vendors Act, 2014, the Government of Telangana, has made the scheme called Telangana State Street Vending Scheme, 2016 vide G.O.Ms.No.11, MA&UD (UBS) on 05.01.2016. Sl.No. 18 of the scheme states about the details of Constitution of TVC, functions and records to be maintained by TVC.

The Town Vending Committees should be constituted in all newly formed ULBs with the following Officers/ Members headed by the Municipal Commissioner concerned.

- 40% of the members from Street vending community
- 20% from ULB and other Govt Departments (local authority, planning authority and Revenue)
- 10% from Police Department
- 10% representatives from Banks and LIC
- 10% elected members of ULB (Area/ Ward Sabha representatives of CBOs)
- 10% from NGOs, Professional groups (Lawyers, doctors, town planners, architects

Total members in the TVC based on population of ULB are as follows:

- 10 members committee in ULBs having less than one lakh population
- 12 members committee in ULBs having more than a lakh population
- 15 members committee in the Corporations
- 18 members committee in all Mission Cities

Therefore, the Municipal Commissioners mentioned in the address entry are directed to constitute the Town Vending Committee in concerned ULB as per the Telangana State Street Vending Scheme, 2016 on or before 30.11.2019 and submit the compliance report along with the details of TVC members to the undersigned without fail.
