In view of the above, it is decided to release an amount of Rs.1,22,46,952/- (Rupees One Crore Twenty Two Lakhs Forty Six Thousand Nine Hundred and Fifty Two only) to the Project Directors, MEPMA in the State to meet the expenditure towards Salaries/remuneration of COs working at ULB level under UCDN component and A & OE for the 1<sup>st</sup> quarter of 2013-14.

The Finance Manager, MEPMA is hereby authorized to draw an amount of Rs.1,22,46,952/- (Rupees One Crore Twenty Two Lakhs Forty Six Thousand Nine Hundred and Fifty Two only) under UCDN component to meet the expenditure towards Salaries/remuneration of COs working at ULB level and A & OE for the 1<sup>st</sup> quarter of 2013-14 and disburse the same to the Project Directors, MEPMA in the State as per the Annexure through e-transfer.
