I invite your attention to the subject and reference cited. In the reference cited, the Managing Director, Hyderabad Metro Rail Ltd., Hyderabad has informed HMRL proposed to develop the commercial area of the AIMPC catering to the needs of women i.e., all the requirements of women shall be made available in the complex and the commercial area will be allocated to the entrepreneurs, who propose to sell the women centric material.

# Pre-conditions for setting up of stalls:

- HMRL will provide the stalls to the SHGs with cost of Rs. 8000/- + electricity charges (actual) for 60 days. Payment should be made by participant.
- Stalls will be allotted those who submit DD for Rs. 8000/- in favor of "Hyderabad Metro Rail Ltd" by 12.04.2019.
- Accommodation for the SHG women provided within the Exhibition premises only with common Toilets and Bath room facilities
- Project Directors of DPMUs shall issue ID cards to the participants.
- Transport arrangements have to be made by the participants (own arrangements) to reach Hyderabad by 12/04/2019 to take over the allotted stalls.
- Participants can prepare their display boards in **cloth banners** for display at their stalls consists of SHG name, place/town, product's name, promoted /supported by MEPMA etc.(Type design will be given by PD)
- Participants are instructed not to use plastic bags and alternatively use non woven bags.
- All the participants should follow Exhibition dress code.
- Using Cylinder or electrical stoves in the stalls is strictly prohibited.

Therefore, the Project Directors, DPMUs and the Addl Commissioner of GHMC are requested to send the information in the prescribed Proforma to reach this office on or before 10-04-2019, so as to enable this office to furnish information to the HMRL
