**Sub:-** MEPMA – SSU – Guidelines for implementation of Janata Personal Accidental Policy for Abhaya Hastam nominees –Data Updation – Reg.

**Ref:-** Lr.No. 1864/SERP/SSU/2014 Dated:- 01.08.2014 of the Chief Executive Officer, SERP, Hyderabad.

It is informed in the reference cited, by the CEO, SERP, A.P that an amount of Rs. 7,64,87,760/- was paid to the UIIC, for coverage of nominees of ABH members under Group Janata Personal Accident Insurance Policy at Rs. 15/- per member for 50,99,184. Out of the said members 21,52,360 belong to the Districts of Telangana State. The decision was taken to implement Janata Personal Accidental Policy for Abhya Hastam Nominees (except Grand Son, Grand Daughter and other Legal heir) in the age group 18-60 Years during the meeting held in SERP. Accordingly the premium amount was paid by the SERP to UIIC. The details of the scheme are as under:

- Eligibility: Nominees of Abhya Hastam members in the age group 18-60 Years (irrespective of member covered in any other insurance schemes implemented through SERP)
- **Premium:** Rs. 15/- per Member per annum (Already paid by SERP)
- Service charge: Rs. 10 per member per annum (The service charges Rs. 6/- for ZS and remaining Rs. 4/- for MS (i.e. Rs. 3 to VET and Rs. 1 to TLF /MS Data Entry Operator for each member)
- Coverage: Accident resulting in Death, Permanent total disablement, Total and irrecoverable loss of use of limb, Loss of eye sight. In the event of accidental injury, it provides compensation as follows:

- o Total Sum Insured Rs. 1.0 Lakh
- Death or permanent total disablement 100%
- $\circ$  Loss of two limbs or two eyes or one limb and one eye 100% of sum insured.
- Loss of one limb or one eye 50% sum insured.

Hence all the Project Directors of MEPMA are requested to issue necessary instructions to collect the eligible member's data from respective call centers and fill the information of the Abhayahastham nominees and submit to APM/TMC, TLF/MS for updating the details in Web. Further instructions may also be issued to update the missing details of the nominees of Abhayahastham members in respective TMC/TPRO Logins of AABY web site of Abhaya hastham by 20.10.2014 so that policy bonds can be issued.
