## **ORDER:**

In the reference  $1^{st}$  read above the Project Sanctioning Committee (PSC) has approved proposal for Construction of Shelter for Urban Homeless (SUH) in government .Hospital in Sangareddy ULB with Total project cost of Rs 30.00 Lakhs .Accordingly the Mission Director MEPMA vide ref  $2^{nd}$  and  $5^{th}$  cited has released an amount of Rs 24.Lakhs towards  $1^{st}$  and  $2^{nd}$  instalment of 80% Project Cost.

Vide reference  $3^{rd}$  to  $5^{th}$  cited the Municipal Commissioner Sangareddy and Project Director MEPMA Sangareddy District has submitted the Utilization Certificate to the funds which were released towards construction of shelter and has requested to release balance funds of Rupees 6,000,00/- .
