ORDER:

Vide reference 1st cited, the GOI has given guidelines under NULM to establish City Livelihoods Centers (CLCs) in all ULBs of NULM towns. The concept of CLCs is to bridge the gap between demand and supply of the goods and services to the urban poor.

In this regard, Each CLC will be provided a non recurring grant of Rs. 10 Lakhs as untied funds and the amount will be released in 3 installments. The milestones for release of installments may be as follows.

- > 1st insta1lment 30% released by SULM to ULB within one week of the proposal, sanction order is approved.
- > 2nd Installment 40% after the staff of CLC is recruited.
- > 3rd Installment 30% will be released offer launch of CLCs.

As per the reference 2nd and 3rd cited above, the Mission Director, MEPMA released an amount of Rs. 3.00 Lakhs in 1st installment and Rs. 4.00 Lakhs in 2nd installment.

In the reference 3rd cited above, the Project Director, Siddipet district is requested to release 2nd & 3rd Installment i.e. 70 % funds an amount of Rs. 7.00 Lakhs for Honorarium to staff of CLCs –Siddipet ULB and maintenance charges.

And also submitted the staff details as One CLC –Resource person, DEO and attendar working since 19.03.2016.

With reference to the 4^{th} read above the proceedings is cancelled due to change of address of existing CLCs , it is decided to release an amount of Rs.4.00 Lakhs for second installment towards Resource feed to staff of CLCs-Siddipet ULB of Siddipet District is detailed below with revised proceedings .

And 3rd installment will be released later after submission of functioning report on CLC

The details of the budget towards CLCs in the ULBs of NULM towns are detailed below:
