## ORDER:

The Government in the 1<sup>st</sup> read above, have sanctioned honorarium @ Rs.4000/-(Rupees four thousand only) per month per Resource Person working through SLFs/TLFs/TVSs under MEPMA & GHMC, in addition to the honorarium paid by the concerned SLFs/TLFs/TVSs in the Telangana State.

- 2) Accordingly, The Project Directors while submitting the UCs they are requested to release the honorarium to their Resource Persons (RPs) for the month of March 2023.
- 3) Therefore, after careful examination of utilization certificates submitted by the respective PDs, sanction is hereby accorded for release of Rs.2,25,33,860/-(Rupees Two crores twenty five lakhs thirty three thousand eight hundred and sixty only) to the Additional Collectors, LBs, for payment of honorarium to the <u>5634</u> Resource Persons (RPs) working in ULBs of Telangana State, MEPMA for the month of March'2023.
- 4) In view of the above, The Finance Manage, MEPMA, is hereby authorized to claim an amount of Rs. 2,25,33,860/- (Rupees Two crores twenty five lakhs thirty three thousand eight hundred and sixty only) and release to the Project-Directors, DPMU-MEPMA and Commissioner, GHMC, for the amounts shown against their Districts in the statement annexed, towards payment of honorarium to 5634 RPs, and any balance amounts accrued can be paid towards succeeding months on receipt of the Utilization Certificates by the Project Directors and also requested to obtain UCs for the released amount and furnish the same to the Admin wing by 10<sup>th</sup> of every month without fail.
- The PDs / MCs, DPMU-MEPMA, are hereby instructed to pay the honorarium to the Resource Persons working under MEPMA & GHMC through SLFs/TLFs/TVSs, from the above released amounts including available honorarium amount with concerned PDs as shown in submitted Utilization Certificates by the PDs to the earlier released funds. Further, instructed to release as per the guidelines issued earlier, after due verification on the basis of monthwise attendance, performance report of MEPMA activities, like Bank linkage, Repayments by Groups, Health & Sanitation, TKHH, Street Vendors, Social Issues etc., and Resolutions of the concerned SLFs, TLFs & TVSs, duly obtaining certification from the authorized person of the Municipalities / Corporations.
- 6) The PDs are requested to acknowledge the receipt of amount and shall furnish the expenditure particulars and utilization Certificates to this office by 5<sup>th</sup> of every month to release RPs honorarium by 1<sup>st</sup> of every month and to submit the same to the Government and to the Accountant General, Hyderabad. If failed to submit UCs, severe action will be initiated without any further notices.
