released an amount of Rs 26.56 Lakhs towards  $1^{st}$  instalment of 40% Project Cost for refurbishment of the shelter

In the reference  $1^{st}$  read above the Project Sanctioning Committee (PSC) has approved proposal for refurbishment of Shelter for Urban Homeless (SUH) in Suryapet ULB with Total project cost of Rs 14 Lakhs .Accordingly the Mission Director MEPMA vide ref  $2^{nd}$  cited has released an amount of Rs 5.60.Lakhs towards  $1^{st}$  instalment of 40% Project Cost for refurbishment of the shelter and Rs 6 Lakhs for O& M funds .
