**ORDER:**

In the reference 1<sup>st</sup> and 2<sup>nd</sup> cited, detailed guidelines are communicated for sanction of Revolving fund to SHGs of PWDs under NULM and its utilization.

In the reference 3<sup>rd</sup> cited above, the Additional Commissioner, UCD,GHMC has submitted the proposals for 63 SHG groups and Bank pass books while requesting to sanction RF to SHGs of PWDs.

In this regard, the proposals are verified and the eligible are 49 SHG of PWD groups Therefore sanction is accorded for payment of **Rs. 4,90,000/-** ((Rupees. Four Lakhs Ninety Thousand only) @ 10,000/- for each SHG from SM & ID component of NULM. The details are as follows:

Further, the Additional Commissioner, UCD, GHMC are informed that, the amount should be released to the SHGs of PWDs Bank Accounts immediately without fail as per the guidelines communicated mentioned below.

1. Additional Commissioner, UCD, GHMC should draft a circular in Telugu regarding utilization of RF and handover to the president, TLF before release of funds to the ULBs with a copy to Mission Director, MEPMA, Hyderabad.

2. Additional Commissioner, UCD, GHMC will issue proceedings with the approval of the Commissioner, GHMC for releasing the amount as per eligibility along with updated online transfer to SHGs of PWDs as mentioned in the proceedings. The Additional Commissioner, UCD, GHMC should not release amount without online updation of SHGs of PWDs and duly scrutinizing with earlier releases.

3. The respective circles of DPOs also instructed to ensure that, the above funds would fulfill the SC/ST Sub- plan and furnish the particulars of % of SC, ST beneficiaries benefited through above funds.

4. The registered Town Vikalangula Samakyas resource persons (TVS RPs)/Community organizers would be trained in utilization of CEF/RF fund. Proper utilization will enable the TVSSs to access further financial assistance in the form of Bank loan etc., in future.

5. A public function duly inviting public representatives can also be held for inviting all the TLFs/TVSSs to explain the concept of Revolving Fund to SHGs of PWDs and its proper utilization as per the guidelines communicated vide ref.2<sup>nd</sup> cited above.


6. The Additional Commissioner, UCD, GHMC is directed to release the above sanctioned Revolving fund amount directly to the SHGs accounts.

Hence, the Commissioner, GHMC is requested to meet the expenditure of **Rs. 4,90,000/-** ((Rupees. Four Lakhs Ninety Thousand only) towards Revolving Fund to SHGs of PWDs for the above mentioned circles of GHMC from the unspent MEPMA funds available at GHMC.
