

I invite your attention to the reference cited, wherein the Deputy Secretary to the Government of India, MoHUA has informed that as per the clause 11.6 of Operational Guidelines of SUH, there is provision for Operation and Maintenance cost for shelters upto 5 Years period under DAY-NULM and requested to take timely action for alternate resources for O&M of shelters after 5 Years of period.

Further, informed that as per the clause 13.6 of Operational Guidelines of SUH, every shelter should be linked with a high school or college, so that the students can engage with the residents of the shelters, ensuring quality of the shelters and learning community service and requested to confirm the action taken for achieving convergence with the community.

Hence, the Commissioner, GHMC and Municipal Commissioners mentioned in the address entry are requested to take necessary actions on the clauses 11.6 & 13.6 of the Operational Guidelines of the Scheme of Shelter for Urban Homeless, if not already done, and submit the action taken report on or before 30th September 2018.

Further, the Project Directors, MEPMA mentioned in the address entry are requested to monitor and ensure necessary action taken on above mentioned clauses in the Operational
