

The attention of all the staff members under the control of this office and noted in the address entry are invited to the references, and it is to inform that as per the standard instructions of Government, the Annual Property Returns have to be submitted promptly in terms of Sub-Rule 7 of Rule 9 of A.P.Civil Services (Conduct) Rules, 1964 and as amended from time to time, by 31st January of every year, by every Government employee, other than a member of Telangana Last Grade Service and a Record Assistant in Telangana General Subordinate Service in the forms prescribed in Annexure-I and II separately before 31 January of every year.

- 2. Therefore, all the staff members of this office (except last grade service employees, Record Assistant & Drivers) may be instructed to submit a statement showing of all Immovable Property/Properties whose value exceeds Rs.1,00,000/- owned, acquired, or inherited by him/her or held by him/her on lease or mortgage either in his own name or in the name of any member of his family, in the forms prescribed in Annexure-I and II separately on or before 31.01.2020.
- 3. Any failure in this regard will be viewed seriously and action will be taken against the concerned, based on the Government Circular.Memo.No.695/Ser.C/2006, dated.12.10.2006.
- 4. The Superintendents, A, K & M-Sections are instructed to take action to obtain the A.P.Rs from the Gazetted and Non-Gazetted categories in ULBs.
- 5. Further, all the RDMAs in the state are requested to take necessary action to obtain A.P.Rs from the Staff members working under their control and to furnish a consolidated report in this regard to this office.
- 6. The Managing Director, TUFIDC Ltd., Hyderabad and the Mission Director, MEPMA, Hyderabad are requested to obtain the A.P.Rs of the staff members of this office working on deputation/working arrangements in their organizations and furnish the same to this office.
