2. The Ministry of Housing and Urban Affairs, Government of India has amended certain paragraphs of various clauses of operational guidelines of Shelter for Urban Homeless with the approval of Executive Committee (EC) of DAY-NULM.

3. The amended provisions are as follows:

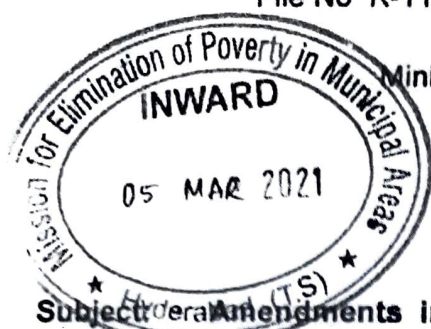
