In the reference 1<sup>st</sup> cited above, the MEPMA has entered into the MOU agreement between MEPMA and NUHM where in the MEPMA recognized has development partner for implementation of community process of NUHM (National Urban Health Mission).

In the reference 2<sup>nd</sup> cited above, guidelines have been communicated to constitute 2 MAS (Mahila Aroghya Samitis) per Slum Level Federations(SLFs) and to open the bank account to each MAS with Joint in the name of President of SLF and ASHA/Health CRP who is member secretary of MAS.

In the reference 3<sup>rd</sup> cited above, the MD, National Health Mission (NHM) budget was released to MD, MEPMA towards United Funds to Mahila Aroghya Samities (MAS) of MEPMA for 41 NUHM ULBs.

In the reference 4<sup>th</sup> cited above, Project Directors are directed to verify the online MAS account statements and submit the proposal for releases of Untied Fund to MAS for the Year 2016-17 up to Dec 2<sup>nd</sup>, 2016.

1. The Project Director, MEPMA should draft a circular in Telugu regarding utilization of MAS fund for Community Health issues and handover to the president, before release of funds to the ULBs with a copy to Mission Director, MEPMA, Hyderabad.
2. The Project Director, MEPMA will provide copy to the proceedings to the District Collector, for released amount as per eligibility along with updated online information in favour of the SLFs through online transfer.
3. SLFs OBs & Slum level resource persons (SLF RPs)/Community organizers would be trained in utilization of MAS fund. Proper utilization will enable the SLFs to access further financial assistance in form of Bank loan etc., in future.
4. A public function duly inviting public representatives can also be held for inviting all the SLFs to explain the concept of MAS and its proper utilization as per the guidelines communicated vide ref.2<sup>nd</sup> cited above.
5. The Project Director, MEPMA is directed to release the above sanctioned MAS fund amount directly to the MAS accounts of SLFs of concern ULBs.

Therefore, Sanctioned is accorded for the payment of Rs Rs.4,65,000/- ( Rupees. Four Lakhs Sixty Five Thousand only) ) towards 93 accounts may be released directly to the MAS accounts of SLFs through online transfer from MEPMA Head Office by TCS (Tata Consultancy Services)

Hence, the Finance Manager, MEPMA is requested to release an amount of Untied Fund to Siddipet District for 93 MAS groups is Rs.4,65,000/- ( Rupees. Four Lakhs Sixty Five Thousand only) towards release of MAS United Funds for the year 2016-17 in favour of the MAS accounts of Siddipet ULB of Siddipet District as mentioned in the annexure enclosed .

The above funds may be released directly to the MAS accounts of SLFs through RTGS (online transfer) from Finance Department , MEPMA Head Office
