The attention of all the Project Directors is invited to the reference cited wherein Government have sanctioned 70 posts under RYK for MEPMA to utilize the services upto financial year of 2014-15 in different categories like Mission Manager (1), Project Manager (3), MIS Manager (1), Senior Assistant (1) Asst. Project Manager (AD Cadre) (22) Dist. LH Specialists (22) and MIS Assistants (22).

In this regard, it is to inform the duration of the project for the said posts is until end of 2014-15 financial year ie., by 31-03-2015. In the reference 2<sup>nd</sup> cited, the DMCs (LH) & MIS Assistants working under RYK have requested to continue their services beyond 31-03-2015. In the reference 3<sup>rd</sup> cited, the PD, MEPMA Nizamabad has also accorded permission to utilize the services of DMC (LH) and MIS Assistant for further period.
