The attention of the Commissioner, GHMC, CEO, SCB and MCs of all ULBs is invited to the sub. & refs. cited, the Secretary, MoHUA, GoI have informed to organize month-long campaign to meet the objectives of PM SVANidhi scheme and thereby improve the quality of life & livelihoods of Street Vendors.

- 2 . In this regard, it is proposed to organize month- long campaign from 02.05.2023 to 31.05.2023 with a caption "Pattana Pragathi Street Vendors Development PM SVANidhi Mai Bhi Digital" in all ULBs for taking up following activities:
- ULBs to organize camps daily based on the potential for disbursement of loans, issue of QR codes, training to SVs etc.
- ULBs to mobilize new first loan applications from SVs and also mobilize SVs to bank branches whose applications are already pending for sanction or disbursement
- Bankers to sanction and disburse all pending loans in f^t, 2nd & 3rd tranche
- ULBs to review "Return by Banks" applications and send valid applications back to banks with the consent of SVs.
- Implementation of new incentive schemes for digital transactions by Banks/ DPAs:
 - Revised cashback for SVs (Rs. 1/- per transaction upto Rs. 100/- per month)
 - Incentive to banks/ DPAs for digital onboarding
 - Rs. 150/- for digital onboarding
 - Rs. 150/- for sustained digital activity
 - Incentive for providing sound box to SVs
 - Rs. 200/- for device to banks / DPAs
 - Rs. 100/- per month for 6 months for SVs for sustained digital activity
 - Training to SVs regarding revised cashback, benefits of Digital transactions,

repayment of loans, etc.

- 3. Further, vide ref 3rd cited, sanction was accorded for an amount of Rs. 1500/-(Rupees One Thousand Five Hundred Only) for each camp towards Logistic Arrangements [Chairs, Tables, Tent (if required), Drinking water, Stationary items, Misc, etc]. The same amount shall be sanctioned for these camps also.
- 4. Hence, the Commissioner, GHMC, CEO, SCB and MCs of all ULBs are requested to organize camps from 2nd May 2023 to 31st May 2023 in coordination with Bankers and Digital Payment Aggregators and ensure mobilization of SVs, sanction and disbursement of all pending loans, implementation of new incentive scheme, digital on-boarding of all inactive SVs and provide training on digital transactions. The camp wise details shall be submitted to undersigned in the prescribed format (enclosed) for release of funds towards conduct of camps.

It is therefore requested to take necessary action in the matter.
