At the outset the Principal Secretary to Government, MA & UD Department welcomed the guests and explained the policy being adopted for Urban Homeless Poor.

Elaborate deliberations were held on the policy including comprehensive strategy on enumeration of the homeless in all the Urban Local Bodies (ULBs), conduct of regular medical checkup for the shelter residents and providing various entitlements to all the residents. The Chief Advisor to Government. Telangana informed that the rehabilitation of the Urban Homeless should be well thought out entitlements including date of birth certificates, and dignified shelter but also their health check up & medical counseling, pensions, opening of Jan Dhan Bank account and skill upgradation& training leading to meaningful employment.

The Principal Secretary to Government, MA & UD Department has informed regarding the progress made with respect to providing Aaadhar Cards, Voter ID preceding paragraph.

After detailed deliberations, the following decisions / recommendations were taken:

- 1. The survey has been conducted in all ULBs to asses the actual number of the homeless. A detailed review meeting is planned on Aug 19th,2019 to get the findings so as to match them with the capacity in the existing shelter homes and find the gaps if any ULB wise.
- 2. To address a letter to the Special Chief Secretary, Medical and Health Department to involve all the Urban Health Centers in the ULBs to provide regular medical checkup to the shelter residents and to arrange for the eyelenses under the "Kanti-velugu' scheme.
- Commissioner Hyderabad and Warangal shall identify suitable sites of 1 acres each for constructing of model shelters as per the NULM guidelines and submit with plans and estimations to the Project Sanction Committee (PSC) for approval and forwarding to GOI.
- 4. To explore the possibility of having at least one model shelter in the District Head Quarter by utilizing the TUFIDC funds.
- 5. To workout type design for the model shelter for (i) Men, (ii) women and (iii) families with common kitchen enough Ventilation and submit with estimation for approval of the PSC.
- 6. To instruct all the Project Directors of the MEPMA & UCD GHMC to provide 100% entitlement to all the residents of the shelters.
- 7. To identify eligible reputed NGOs with past experience in providing care to the vulnerable section of the Society to manage the urban shelters.
- 8. To address the GoI to issue guidelines through the RBI to all the Banks to open account for Shelter residents by taking the shelter as the address for them, as they are facing problem in opening of Bank accounts on this account.
- 9. To advice the Commissioner, Civil Supplies, Telangana for providing the supply of rice allocation for the Shelter residents at concessional rates.

10. To evolve a common policy for conduct of social audit of the shelters to submit a report to the Hon'ble Supreme Court, India.
