The attention of all the Municipal Commissioners in the state is invited to the subject and references cited.

2. The instructions were issued to organize special campaign in the caption "**Pattana Pragathi – Main Bhi Digital**" from 04.01.2021 to 22.01.2021 vide ref 7th cited for Sanction, Disbursement of pending loans, Digital on-boarding and Training to Street Vendors, conduct penny drop transaction (debit and credit) and to educate the SVs for timely repayment of loans in order to be eligible for interest subsidy and for next higher tranche of loan. Accordingly, as per online report, 629 camps were organized and 35,531 SVs attended the camps out of 2,40,687 SVs (loans disbursed).

3. In view of this, the Joint Secretary, MoHUA, GoI vide ref 8th cited, has requested to organize camps till 15th Feb 2021 in order to cover all the Street Vendors for whom loans are disbursed.

The camp wise details shall be submitted to undersigned in the prescribed format (enclosed) without fail for release of funds towards conduct of camps and also to update in portal.
