The attention of the Commissioner, GHMC and all the MCs in the state is invited to the references cited, and it is to inform that as per para no. 4 (iii) & 5 of guidelines of PM SVANidhi Scheme, Street Vendors, left out of the survey or who have started vending after completion of the survey have to be issued Letter of Recommendation by the ULB/ TVC.

- 2. Further, vide ref 1st cited, the Secretary, MoHUA, GoI has requested to formally recognize these vendors as per the provision of Street Vendors Act, 2014 and issue them Certificates of Vending (CoV) and Identify Cards (IDs) within one month of issuance of LoRs.
- 3. In view of the above, the Commissioner, GHMC and MCs of all the ULBs are requested to complete the task of issuing of CoVs and IDs by 10th April 2021 to the vendors who have been issued LoRs. This step will go a long way to provide these nano-entrepreneurs the protection, as envisaged by the Act, which will enable them to carry out their business in a peaceful manner without the threat of undue harassment and illegal eviction.

It is therefore requested to take necessary action in the matter.
