Sub : MEPMA-NUHM –KANTI VELUGU-Universal Eye Screening in the State By Health , Medical & Family Welfare Department – 15th August 2018 to January 2019 - Modalities for conducting the camps –mobilization through SHGs and SLFs –Certain instructions issued –Regarding .

I invite your kind attention of the Project Directors in the state are invited to the reference cited wherein the Health, Medical & Family Welfare Department are going to conduct the KANTI VELUGU Universal Eye Screening in the State from 15th August 2018 to January 2019 for six months period to work towards "Avoidable Blindness Free Telangana . And camps will be conducted from Monday to Friday in a week excluding Saturdays and Sundays and other Public Holidays .

The objective of the KANTI VELUGU Programmme are

- To conduct eye screening & Vision test for all citizens of the state
- To provide spectacles free of cost
- To provide referrals in all required cases at secondary/tertiary hospitals and arrange for surgeries and other higher expert care.
- To provide medicines for common eye ailments
- To educate people on prevention of serious disabling eye diseases.

Accordingly from Municipal Administration department will be going to provide the basic infrastructure and other related logistic arrangements for KANTI VELUGU Eye camps .

In this subject for mobilization of the persons for Eye camps through SHGs/SLFs are allotted to MEPMA Staff . in this regard the following activities to be facilitated by MEPMA DPMU unit in all ULBs including new ULBs

1. **Role of the Project Director** : In co-ordination with concern Municipal Commissioners collect the information on eligible persons for KANTI VELUGU Eye camps in all ULBs including new ULBs and also facilitate the program effectively to cover all the Poorest of the poor to avail services of above said Eye camps . And also to be able to conduct extension out reach camps in slum areas covering in all vulnerable population including inmates in shelters (Shelter for Urban Homeless) .**PD has to distribute the work order to MEPMA staff to all ULBs for facilitation of the camps .**

2. **Role of DMC** : DMC should coordinate with the field staff of TMC, ADMCs and COs of MEPMA and facilitate the KANTI VELUGU Eye camps in all ULBs . And submit the Day wise report to Head office .

Tot Trainings: ULB wise Orientation trainings on Mobilization process of KANTI VELUGU Eye camps to be conducted by all DMCs in Municipal Community Halls to all field staff of MEPMA , SLF & TLF OBs , and including Health CRP Tot from 9th August to 14th August. And submit the report to the concern Municipal Commissioner and to the MEPMA Head Office in the prescribed format .

3. **Role of ADMC:** ADMC should report the Day to Day Progress of activities related mobilization to the concern DMC .

4. **Role of TMC and COs :**

➤ TMCs and COs are to be facilitate the information on **KANTI VELUGU Eye camps** in all TLFs, SLFs and SHGs.

➤ **Identify the new active Health CRP Tot @ one person per SLF in new ULBs and other than NUHM ULBs and in NUHM ULBs** identify the trained Health CRP tot for house to house visit and mobilization of person to the venue as per the schedule dates of the camps . And resource fees will be paid to all Health CPT Tot as per their work done report.

➤ Agenda of the mobilization to be documented in all SLFs , TLFs meetings and Format to be generated on the list of House holds and eligible persons for Eye Camps as per the distribution of tokens to Health CRP Tot /Identified new Health CRP .


➤ And Concern COs and TMCs has to be prepare the Ward wise Action plan on mobilization of **KANTI VELUGU Eye camps and report to be submitted to the concern Municipal Commissioners and DMCs.**

➤ Day –To Day Activities on mobilization report as per the distributed Token list to be submitted to the DPMU office.

5. **Health CRP Tot** : Identify Health CRP Tot in new ULBs and with exiting Health CRP tot under NUHM scheme facilitate the mobilization of the persons for eye screening camps in all ULBs including merged gram Panchayats . Health CRPs , (SLF wise) are directed to visit each household and provide them tokens to avail the medical services in Eye Camps. And also provide the information to each house hold on Date , time and serial number in the token for the attending the eye camp.

6. **Mobilization Process:** As per the venue and commenced dates, Health CRP tot has to be provide the tokens to all the eligible persons . Mobilization should be done in all ULBs including new ULBs .And resource fees will be provided to CRPs as per the MEPMA norms

Hence all the Project Directors are directed to facilitate the KANTI VELUGU Eye camps for mobilization of the persons through SHGs/SLFs to avail the medical services in the Eye camps through MEPMA field staff in co-ordination with Municipal Commissioners from 15th August 2018 to January 2019 for six months period and the submit the report on Day to Day activities of the Eye camps to Head Office.
